- 1. Treasurer Rachael called the Meeting to order at 6:03 pm. The meeting started without a quorum.
- Affirmation Statement
  Derek read the affirmation statement for the group.
- 3. Due to not reaching quorum, we have held off on approving November 2023 meeting minutes and the January 2024 agenda until the February 2024 meeting.
- 4. Nicole Rapacki from the Department of Public Works shared more information around the city's goal of increasing recycling rates. Grand Rapids is currently at a 30% recycling rate and the goal of the city is 45%. Visit the city of Grand Rapids public works <u>website</u> for more information!

- 7. Staff report: Steve shared more information on a "Winter Bleus" champagne and cheese tasting event / fundraiser at Pursuit of Happiness on January 21st. He also outlined ongoing challenges between Aquinas College and neighbors on Norwood Ave due to noise pollution. There is a fan which makes a loud noise which can be heard inside the house all day (until 9pm). There is a neighbor with expertise in HVAC fans who would be willing to take a look and hopefully repair the fan. The board decided that a good next step



would be to reach out to Katharina Häusler-Gross at Aquinas to see if there is a potential path forward. Steve also discussed challenges that Eastown residents are facing in terms of extremely bright street lights. The proposed action plan is for individual residents to ask for special ADA accommodation. Steve has a template / resources available for neighbors interested in pursuing ADA accommodation.
